- Access conditions:** Conditions of Accession to - C.T.T. TECHNICAL TEST is defined in Annex II. Eligible candidates (1.1.2) **COMMISSION DELEGATED REGULATION (EU) of 14.3.2019** establishing a common qualification test for ski instructors pursuant to Article 49b of Directive 2005/36 / EC of the European Parliament and of the Council of 7 September 2005 on the recognition of professional qualifications - Eligible candidates (1.1.2)
- Applications:** Applicants may only apply through SITAS by filling in the attached form by **February 1<sup>st</sup> 2024** and sending it to [zuts@sloski.si](mailto:zuts@sloski.si) Individual applications shall not be accepted. The applicants – ski instructors from abroad – must also gain a signature by person responsible and the stamp of the ski training programme holder.
- Competition:** The competition takes place in two courses.

**Inspection:** From 9.00 to 9.15 with a visible start number.

**Results:** Results are announced after their analysis at the finish area.

**The right to appeal:** 15 minutes after the competition is finished, fee € 50.00.

**General provisions:** Competitors compete at their own risk. In case of bad weather and snow conditions the organiser reserves its right to postpone or even cancel the competition. C.T.T. TECHNICAL TEST and training shall take place if **minimum 40 up to 100 competitors apply/per day.**

**The use of race certified ski helmet, GS skis and competitive ski wear is obligatory.**

In case of inexcusable absence the fee is not refunded.  
In case of unjustified absence of the registration fee, we do not refund.

All participants - candidates and coaches are informed that they attend the technical test at their own risk. That's why we advise them to take out pre-insurance - both in case of an accident and against a third party on the course. In the event of an accident, the training organizer and C.T.T. the test assumes no responsibility.

In case of worsening of epidemiological, bad weather and snow conditions, the organizer joins to cancel or postpone the time and place of the technical test.

**Training:** Candidates can train at the same slope. Training takes place before the race. Candidates who decide to train on Monday, February 12<sup>th</sup> 2024 at 9 am must appropriately mark it on the registration form. Training fee is €70,00 which must be transfer on the above IBAN.
