»SKI GUIDE«

ZUTS/SITAS (Ski Instructors and Trainers Association of Slovenia) announces the course »Ski Guide«.

The meeting of the course participants and the introductory meeting are scheduled for November 23 2025, at 7 pm, in the hotel.

Any changes and additional dates will be communicated to the selected candidates in time by e-mail.

1. GENERAL INFORMATION (DESCRIPTION AND PURPOSE)

To facilitate reading, only the masculine form is used in the appellation which, of course, always implies the feminine one.

The basic objective of the program is to train the ski instructor in the field of off-piste skiing for guidance and teaching to people and groups of basic, advanced and expert level, as well as for participation in the execution of all skiing activities that take place with the help of motorized ski lifts (ski lifts, treadmill, snowmobile, helicopter, etc.) outside the organized ski area or on its outskirts.

















By passing the exams (theoretical and practical) and the internship, the candidate obtains the diploma of SKI GUIDE. Participation in the theoretical and practical parts of the course, as well as passing the theoretical exam are necessary conditions for access to the safety test (CTT-Safety test), passing which is one of the necessary conditions for obtaining the CTT certificate.

2. CONDITIONS FOR REGISTRATION

To enroll in the Ski Guide course, candidates must meet the following requirements (the requirements apply only to this form of course organization; the regular course will be announced later):

- 1. have acquired the title Strokovni delayer 1 športno treniranje (MAESTRO), at least ex U2,
- 2. are ZUTS members,
- 3. have paid the membership fee to the OO-ZUTS and have the membership of the SZS-ZUTS Slovenia (blue card / Sloski ZUTS) for the current season,
- 4. are at least 18 years old,
- 5. have at least a level IV education.
- 6. have passed a practical placement test, if required for the course and if the course organisers decide to require it. Applicants must have sufficient skiing knowledge to ski safely outside of an unregulated ski area, otherwise they may be excluded from the course.

3. SUBJECT PROGRAM

Subjects and division of hours for the practical and theoretical parts:

Theoretical part: 22 hours

- 1. Avalanche equipment and other mountaineering equipment and their use theoretical part (number of hours: 3)
- 2. Basic notions of orientation in the mountains theoretical part (number of hours: 2)
- 3. Off-piste ski equipment theoretical part (number of hours: 1)
- 4. First aid theoretical part (number of hours: 3)
- 5. Snow and avalanches, dangers in an unorganized ski resort theoretical part (number of hours: 6)
- 6. Technique and tactics of off-piste skiing and methodology for teaching off-piste skiing theoretical part (number of hours: 3)
- 7. Guiding groups and individuals in off-piste theoretical part (number of hours: 3)
- 8. Legislation, rules of conduct and comparison with provisions in other countries theoretical part (number of hours: 1)

Practical part: 40 hours

- 1. Avalanche equipment and other mountaineering equipment and their use practical part (number of hours: 5)
- 2. Basics of mountain orientation practical part (number of hours: 3)
- 3. First aid practical part (number of hours: 2)
- 4. Snow and avalanches, dangers in an unorganised ski resort practical part (number of hours: 15)
- 5. Off-piste skiing technique and tactics and methodology for teaching off-piste skiing practical part (number of hours: 3)
- 6. Guiding of groups and individuals off-piste practical part (number of hours: 12)
- 7. Preparation for the next day (3 x 3 method)

4. PROGRESS CONDITIONS

In the Ski Guide program there is no vertical advancement.

5. CONDITIONS OF COMPLETION

The conditions for completing the course are:

- 1. passing the theoretical exam (from the contents listed in the program),
- 2. passing the practical exam (from the contents listed in the program; passing the practical exam is considered to be passing the CTT safety test or passing a practical exam during the internship),
- 3. delivery of the end-of-course essay (3x3 modules prepared during the course),
- 4. successfully completed internship, which is necessary to obtain the title of Ski Guide (in accordance with the Rules on the Organization and Conduct of Training Courses at ZUTS Slovenia).

The candidate takes the exam before the examination board appointed by the SZS on the basis of the rules of the National Examination Board of ZUTS Slovenia. All obligations for completion must be fulfilled by the applicant within the next three ski seasons.

7. COURSE DELIVERY AND REGISTRATION

The practical part of the course takes place under the guidance of instructors and employees of the offpiste skiing commission of ZUTS Slovenia, while the theoretical lessons are held by the instructors and licensed lecturers, as well as by experts in the specific fields related to the training program.

The theoretical exam consists of a written test on the topics covered in the theoretical lessons and a practical part concerning the following topics: rescue call, analysis of the avalanche forecast, guidance of the group off-piste, search and rescue of two buried avalanches, as well as one of the three modules concerning meteorology, mountain hazards or analysis of the snowpack. The practical exam takes place as part of the safety test or during the internship.

Registration for the course is open to anyone who meets the requirements set out in point II. (registration requirements). The course will be organized in case of a minimum number of 8 candidates (including foreign language participants).

Documents to be sent for application:

- properly completed application form
- copy of the ski instructor certification
- copy of the Modra Kartica/Sloski Card, valid for the current season
- copy of identity document
- copy of diploma/certificate of education
- copy of the payment of the application fee

8. ACCOMMODATION

Candidates enrolled in the course will be informed in good time about the possibilities of accommodation and the purchase of the ski pass.

9. ADDITIONAL INFORMATION

Course participants must pay the application fee of € 740.00, by the dates indicated, to the bank account IBAN: SI56 0400 1004 6477 054 SWIFT/BIC koda: KBMASI2X (OTP bank d.d., Slovenska cesta 58, 1000 Ljubljana).

The course includes all the lessons of teachers and instructors, the lecture notes, the use of video resources, the organization and management of the course and exams, the classrooms, the diplomas, the coats of arms. For non-native speakers, a translator is included in the theoretical and practical part of the course, with the exception of exams. Candidates carry out the internship, which is mandatory for obtaining the Ski Guide diploma, individually with the tutor. To obtain the CTT certificate, the internship is not mandatory.

The costs of food and accommodation, transport and ski passes are the responsibility of the candidates themselves.

Candidates must present themselves for the course with complete avalanche equipment.

Attendance of the course is at your own risk and we recommend that you take out accident and third-party liability insurance. In the event of an accident, the course organizer assumes no liability. In case of bad weather, the organizer reserves the right to cancel the course or move the venue.
